WOOD COUNTY SOLID WASTE MANAGEMENT DISTRICT POLICY COMMITTEE MEETING

November 13, 2017

The Wood County Solid Waste Management District Policy Committee met on the 13th day of November 2017. Commissioner Doris Herringshaw called the meeting to order at 2:00 p.m. The following members were present: Commissioner Herringshaw, Mayor Edwards, Lana Glore, Nicki Kale, Judy Hagen, and Jim Rossow. Additional persons were in attendance as listed on the attached roster. The Agenda was as follows:

- I. Approval of August 14, 2017 Meeting Minutes. Nicki Kale moved that the minutes be approved and Judy Hagen seconded the motion. All members present voted aye and the motion carried.
- II. Solid Waste Management District Update: Assistant County Administrator Kelly O'Boyle reported on the following:

Litter Management Grant Update: Ms. O'Boyle thanked those that helped with the tire collection event. The grant was for \$25,000.00 of which a little over \$17,000.00 was spent. The grant request was based on collecting 5,000 tires and the collection brought in a little over 3,600. The OEPA was pleased with the results and assured the District there will be no penalty for return of unspent funds. The District received a proposal from Enviro Tire Recycling asking if the remaining balance of the grant could be used for an agricultural tire collection. The proposal will be reviewed.

Got Your Bags Update: Campaign brochures and promo items was distributed at one of the Bowling Green and Perrysburg farmers' market events and the information was well received.

Satellite Location Update: Committee members were already informed no quotes were received for the pilot program so that will be revisited at a later date. Bids are due for the current monthly satellite program on November 15.

Annual District Reports: For the 2016 report, the residential and commercial recycling total was 31,749 tons or 20.93% up about 2.69% from 2015 and the industrial total was 116,407 tons or 95.11% up 2.79% from 2015. The Ohio EPA was pleased with the thoroughness of the report. Preparation of the 2017 report will begin in January and it is due in June.

Financials: Patti Bowsher presented a report comparing the District's 2013-2017 September year-to-date revenue, expenses, and cash balance (attached).

Other – Proposed Senate Bill 228: Ms. O'Boyle stated this bill, if passed, would increase the state fees from \$.25 to \$.50 with the additional \$.25 going to the Soil & Water Districts.

- III. Education & Awareness: Ms. Gamby reported on technical, education, & awareness projects since the last meeting (report attached).
- IV. *Landfill/Recycling Updates:* Ms. O'Boyle reported landfill staff are busy preparing for future capping which has been pushed to 2019 due to the unexpected wet spring weather.
- V. *Other Business:* A time change from 2:00 p.m. to 8:30 a.m. was proposed for 2018 meetings. With no issues raised, the 2018 dates of February 12, May 14, August 13, and November 5 at 8:30 a.m. were accepted.

Judy Hagen stated the Perrysburg Holiday Parade will be held on December 3. Mayor Edwards expressed thanks to all involved with bringing glass recycling back for Wood County residents. Nicki Kale reported working on a September 2018 AG Venture event which will include driving tours of seven agricultural sites. Lana Glore reported looking at possible future Ohio EPA grant funding for different projects.

Discussion took place regarding the trees that were logged in the southeast corner of the landfill property.

VI. Adjournment: Meeting adjourned at 2:35 p.m.



Technical Assistance, Education, & Awareness Report: November 13, 2017

A. Education Program Review & Events:

B. 2017 Wood County Fair Follow Up:

Numbers are in for the 2017 attendance in "The Grove" area. 6,187 fairgoers visited displays, which is an increase of over 60% from 2016 (3,802 attendees). The area continues to grow with the 2018 theme selected as "Building Our Future."

C. Folklore & Funfest:

The District provided reusable bags to be distributed during the Wood County Park District/Wood County Historical Museum's Annual Folklore & Funfest. 400 bags were given to families containing information on the "GOT YOUR BAGS?" campaign and the Household Recycling Guide brochure.

D. Tire Recycling Locations Brochure:

The Tire Recycling Locations Brochure was updated and distributed to all who came to the Tire Amnesty Event in an effort to promote every day solutions for proper tire disposal. A copy of the brochure is included with this report.

E. The Morning Show BG:

The District and the WC Landfill have been promoting information on The Morning Show BG radio program with Clint Corpe. Kelly and Amanda provide a live on air monthly interview. Talking points are also read and advertised pertaining to current recycling/disposal information on a regular basis. Clint has also created videos promoting recent District activities that have been shared on social media.

F. Advertising:

Recent advertising has been targeted at promoting the Tire Amnesty Event. A holiday themed "Got Your Bags?" advertisement will appear in the Holiday Edition of the AT HOME IN WOOD COUNTY magazine, which is mailed to all 50,000+ Wood County addresses. An ad will also appear in the Rossford Record promoting the District's Household Recycling Guide, which will reach approximately 7,000 homes.

G. 2017 Education Numbers (Through October 26):

As of October 26th, the District has provided 81 tours and 60 presentations. We've also participated in 16 community events. The website has been visited approximately 16K times by 12K users. 55% are mobile users. The top pages continue to be: Landfill/Disposal Fees; Household Recycling Options; & Yard Waste.
